#### 1. **DEFINITION**

- 1. **Government Database** shall mean such database maintained by Government for authentication or identification purposes;
- 2. **VCIP** shall mean VCIP (Video-Based Customer Identification Procedure) for Customer Due Diligence by its reporting entities by RBI in its circular dated 9th January 2020 and includes:
  - i. VIPV
  - ii. VIBP
  - iii. Digital KYC
  - iv. Third Party Verification

### 2. SCOPE OF SERVICES

The standard Process Flow of Scan.it is that SignDesk shall provide the Service in the manner as more specifically explained in the <u>Workflow</u> and as provided in the **Order Form**;

#### 3. OBLIGATION OF PARTIES

- 1. You warrant and agree that you will comply with all applicable laws and regulations, as applicable to your industry including but not limited to Master Direction issued by RBI, other guidelines and directions issued by RBI, or any other Regulatory Body in India as applicable:
- 2. You warrant that you shall be responsible for obtaining consent of the user for Scan.it for your use of the VCIP Process and the consent can be collected as a part of the Process;
- 3. As per the RBI Master Direction, Prior to use of Scan.it you shall be authorized to audit the Product before utilizing the same. Once the audit is completed, Signdesk shall issue You the "Audit Complete Certificate". SignDesk shall not be held liable for any error in the system once such an Audit Complete Certificate is issued.
- 4. It is Your responsibility to ensure that any Customer Data passed through You is error-free and passed with the consent of the Customer;

- 2. You acknowledge that the Product utilizes technologies such as Artificial Intelligence and Facial Recognition Technology. You accept that SignDesk may use the transactional history, in order to improve its processes and algorithms and Artificial Intelligence.

# 5. VIDEO BASED CONSENT RECORDING SYSTEM
